APOSTILLE OF DOCUMENTS IN KOREA.

According to the Apostille Convention, an Apostille is an international certification that certifies the validity and authentication of public documents between members' countries such as South Korea. South Korea is a member of the Hague Apostille Convention since July 14, 2007. All documents officially issued by any agency of the Korean government can be authenticated by Apostille. Those include documents such as: Company Registration Certificate, Business Tax Certificate, Article of Incorporation, Business License, Certificate of Good Standing, Certificate of Free Sale, Certificate of Trade Business Code.

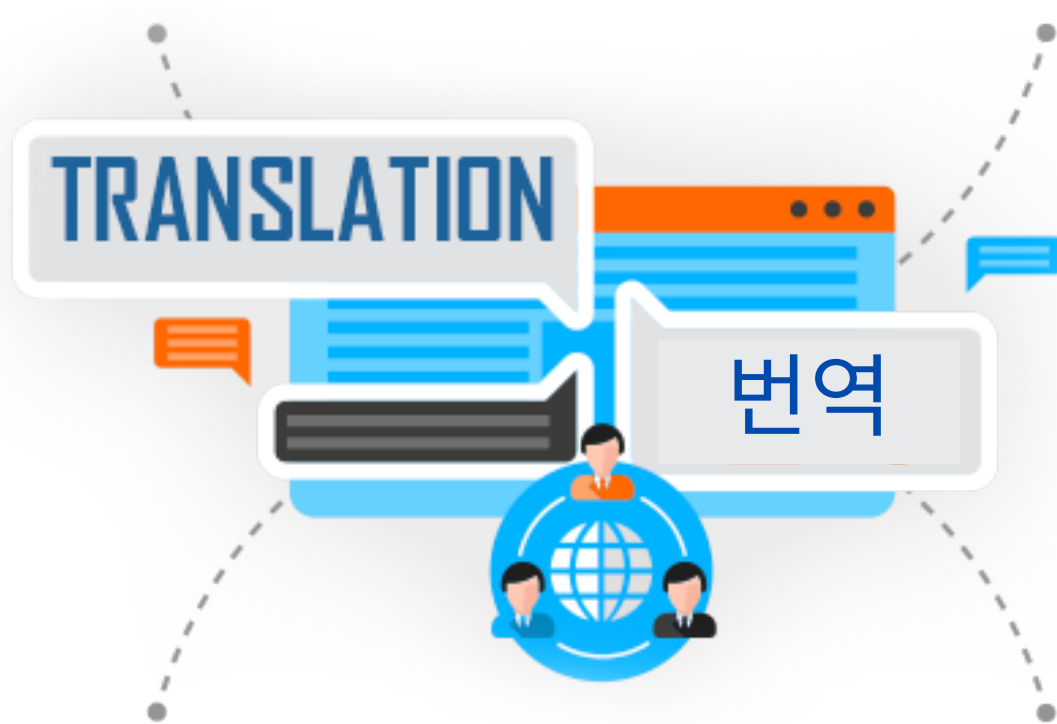
In India Apostille is done by Ministry of External Affairs Division CPV Division Located in Patiala House Delhi, respective documents that has to be either Attested from the state lever from which it has being issued or from Sub Divisional Magistrate of Delhi who is being authorized to Authenticate all Indian documents irrespective of any state in India. DOCUMENT APOSTILLE IN INDIA

CERTIFIED KOREAN TRANSLATION SERVICES

A certified translation (sworn translation) indicates that the translation was done accurately, faithfully, and fully represents the original document. According to the law in South Korea, only Certified Korean translator is authorized to provide certified translation. Each certified Korean translation provided with the translator's name, license number, office seal, direct contact number and an affidavit.

- Personal Documents such as: Marriage Relation Certificate, Driver License, Family Relation Certificate, Birth Certificate.
- Travel Documents such as: Passport, visa applications, Immigration related documents.
- Business Documents such as: Article of Incorporation, Business Registration Certificate, Certificate of Incorporation, Certificate of Employment, Board Minutes.
- Legal Documents such as: Agreements, Contracts, Legal memos, Power of Attorney, Court Decisions, Summary orders.
- Financial Documents such as: Banking notes, Transactional documents, Certificate of Deposit, Utility bills, Financial Statement and Audit Reports.
- Medical Documents such as: Certificate of Cremation, Medical reports, Certificate of death, Drugs Prospection.



GETTING DRIVER'S LICENSE IN KOREA

- Short-term visitors can use an International Driver's License. An International Driver's License is as valid as a Korean driver's license during the term of its validity. You must also carry your regular driver's license with you if you are using an international driver's license in Korea. However, if you are a long-term resident, you must obtain a Korean driver's license.
- Long-term residents can either exchange their driver's license for a Korean one or apply for a local license. If you are given a Korean license by the Korean Driver's License Authority (DLA), your home country license may be held by the DLA and returned to you before you depart Korea.
